MINUTES

1. The Willmar Planning Commission met on Wednesday, January 9, 2013, at 7:00 p.m. at the Willmar City Offices Conference Room #2.

** Members Present: Mark Klema, Charles Oakes, Andrew Engan, Gary Geiger, Randy Czarnetski, Bob Poe, Virgilio Aguirre Jr.

** Members Absent: Scott Thaden, and Nick Davis

** Others Present: Bruce Peterson- Director of Planning and Development Services, Megan Sauer- Planner.

2. REORGANIZATION: Mr. Poe made a motion, seconded by Mr. Geiger to nominate Mr. Klema for Chair, Mr. Oakes for Vice Chair, and Mr. Engan for secretary for the year 2013.

The motion carried.

3. MINUTES: The minutes of the December 12, 2012 meeting were approved as presented.

4. TREE PLANTING/MAINTENANCE EASEMENT VACATION- FILE 13-01: Staff presented a vacation request for a tree planting/maintenance easement which is not well described and does not properly confine the easement. It is described as follows: a strip of land 5' in width, over and across the said property E 100' of Lots 1 and 2 except south 10' of east 100 feet of lot 2, Block 39, City of Willmar. The 5' strip is undefined; it is unclear if it's along 8th St. SW or Litchfield Ave. W (Hwy. 12 W). Staff inquired with Municipal Utilities as well as Public Works as to the necessity of the easement. It was the consensus that vacation of the easement would be best, as defining the easement is unnecessary as there are boulevard trees in the r-o-w along 8th St. SW already.

The Commission talked about the easement not being useful as it is so poorly defined and not even needed for tree planting.

Mr. Geiger made a motion, seconded by Mr. Czarnetzki, to adopt a resolution recommending the tree planting easement vacation to the City Council for a public hearing and action.

The motion carried.

5. TEXT AMENDMENT DISCUSSION- APPEALS PROCESS: Staff presented a possible text amendment to the Commission regarding Section 9.E.5 of the Zoning

Ordinance regarding appeals of actions by the Planning Commission. The amendment would further clarify the section regarding the Board of Zoning Appeals hearing appeals of actions/enforcement of the Zoning Administrator and that an appeal of an action by the Planning Commission would go to District Court. The only exception to the rule is conditional use permits, which action by the Planning Commission can be overturned by the City Council with an 6/8 vote.

The Planning Commission thought this clarified the Ordinance further.

Mr. Engan made a motion, seconded by Mr. Oakes to have a public hearing on the proposed text amendment at an upcoming meeting.

The motion carried.

6. There being no further business to come before the Commission, the meeting adjourned at 7:33 p.m.

NOTICE OF HEARING FOR PROPOSED TEXT AMENDMENT

Notice is hereby given that the Willmar Planning Commission will meet at the Willmar City Office Building, 333 6th St. SW, Willmar, Minnesota, at 7:01 p.m. on Wednesday, February 13, 2013, to consider an Ordinance amending No. 1060 known as the Willmar Zoning Ordinance by amending Section 9.C.1. relating to appeals:

C. APPEALS.

1. Authority. The Board of Zoning Appeals shall hear and decide appeals from and review any order, requirement, decision, or determination made by the Zoning Administrator in the enforcement of this Ordinance. *Any appeal of a decision by the Planning Commission on a Conditional Use Permit, Rezone, or Text Amendment shall be filed directly with the District Court except that in the case of a Planning Commission's denial of a Conditional Use Permit application, no appeal to the District Court shall be made without first applying to the City Council for reconsideration of the decision pursuant to Section 9.E.5 of Ordinance 1060.*

All property owners or residents living in the vicinity of the above-described property are hereby notified of the public hearing and that they may appear in person or be represented by counsel to be heard on this matter.

John,

Radio is impossible without the utilization (and, many times, the manipulation) of technology. In fact, it's so entrenched in the use of technology that without modern advances in communication via satellites and internet, modern day radio stations wouldn't exist. From it's inception, the re-transmission of Presidential addresses and sporting events has been the marvel of the technological world. Popular Mechanics even included radio as their #2 "Gadget That Changed the World". Perhaps due to the ease and pervasiveness in everyday life in the 21st Century, the general public may not realize how technology has played a part in the listener's flawless ability to hear the latest hit song or news broadcast. Headwaters Media, LLC and 94.1 The Loon use the following technologies every day to make their broadcast possible:

- Frequency Modulation: The actual act of broadcasting requires the use of high power, high wattage frequency modulation onto the FM band. Transmitting from our digital studios in Willmar to our analog tower in Atwater requires multiple, modern advances in audio conversion.

- Internet:

a) 94.1 The Loon broadcasts world wide via our web stream. From the encoding/decoding algorithms to the discrete and separate audio processing, technology is at the crux of this budding new technology field. Internet radio is just beginning to gain acceptance in mobile listening, too, via smartphone apps and 3/4G cellular networks. 94.1 The Loon was the first commercial radio station in West Central Minnesota to stream via the internet.

b) 94.1 The Loon acquires various syndicated programs via distribution services over the internet. From NASCAR news updates to local BringMeTheNews broadcasts, our utilization of the internet is essential to the listener being up-to-date.

c) Our traffic (commercial placement) and billing system takes advantage of "cloud storage & computing": our salespeople can enter sales orders via their cell phone, further enabling them to be mobile.

d) 94.1 The Loon can access their on-air feed remotely to change the playlist or even broadcast remotely (more below).

e) Through their constantly updated website, 94.1 The Loon informs listeners of local happenings, school closings/delays, and even the latest song(s) played.

- Cellular networks: Via modern 3/4G cellular networks, listeners can tune to the Loon on a smartphone, and text our studios directly to request songs, talk about music, or inquire about school closings/delays and weather conditions. 94.1 The Loon was also the first in West Central Minnesota to broadcast from remote sites via the mobile internet, enabling studio quality fidelity on a budget, from virtually any where a cell phone works.

- Digital Editing: 94.1 The Loon, since it's beginning in 1999, was on the cutting edge of digital audio editing. Our ability to use advanced, high speed computers, microphone processors and post processing effects help our production staff create professional commercials and programs that inform and entertain.



localized commercials aimed at our regional audience, satellites work in tandem with the internet to provide addition revenue, entertainment and information to our listeners.




Corey Johnson - Announcer






LEFT ELEVATION
